1. Call to order and roll call.
2. Approval of the minutes of the July 17, 2013 Ad Hoc Election Subcommittee meeting.

**LOCAL GOVERNMENTAL UNITS - ELECTIONS (November 16, 2013)**

3. **L13-413 - Iberia Parish Council** - (1) 2.11 mills tax, 10 years, 2014-2023, original and extended authorization rededicated as follows (a) 1.86 mills for acquiring, constructing, improving, maintaining or operating public health units and other related public health activities and (b) 0.25 mills for acquiring, constructing, maintaining and operating levees, hurricane protection, flood control and conservation improvements; (2) 4.76 mills tax, 10 years, 2014-2023, original and extended authorization rededicated as follows (a) 4.26 mills tax for acquiring, constructing, improving, maintaining or operating public buildings and (b) 0.50 mills tax for acquiring, constructing, maintaining and operating levees, hurricane protection, flood control and conservation improvements; (3) 4 mills tax, 10 years, 2014-2023, original and extended authorization rededicated as follows (a) 3.75 mills tax for constructing, improving, maintaining or operating drainage facilities and (b) 0.25 mills tax for acquiring, constructing, maintaining and operating levees, hurricane protection, flood control and conservation improvements; (4) 6 mills tax, 10 years, 2014-2023, original and extended authorization rededicated as follows (a) 5.25 mills tax for acquiring, constructing, improving, maintaining or operating public libraries and (b) 0.75 mills tax for acquiring, constructing, maintaining and operating levees, hurricane protection, flood control and conservation improvements.
4. **L13-408 - Lafourche Parish Council** - 3.80 mill tax, 30 years, 2014-2043, original and extended authorization to be rededicated as follow (1) 1 mills tax for (a) acquisition, construction, operation and maintenance of a new parish jail and (b) funding into bonds; (2) 2.80 mills tax for acquiring, constructing, improving, maintaining and/or operating the public library and its branches, including automation and other equipment, library books and material and furnishings.
5. **L13-414 - Orleans Parish, City of New Orleans, East New Orleans Neighborhood Advisory Commission** - \$5 parcel fee, 4 years, 2014-2017, encourage and promote the beautification, economic growth and overall betterment of East New Orleans.
6. **L13-407 - Rapides Parish, Town of Cheneyville** - 1% sales tax, 10 years, beginning January 1, 2014, recreational park improvements and additions, capital improvement projects, water and sewage system improvements, and police and fire protection services
7. **L13-405 - St. John the Baptist Parish Council** - Not exceeding \$30,000,000 General Obligation Bonds, in one or more series, not exceeding 7%, not exceeding 25 years, (1) \$6,000,000 for constructing and improving public buildings, including expansion of the governmental complex; (2) \$13,000,000 for constructing and improving drains, drainage canals, pumps and pumping plants, dykes and levees; (3) \$3,000,000 for construction, repairs and improvements to parks, playgrounds and recreation facilities; (4) \$3,000,000 for constructing, acquiring and improving public roads, highways and bridges; and (5) \$5,000,000 for constructing and improving the waterworks system, all including acquiring equipment and furnishings.

8. **L13-406 - St. Mary Parish, Water and Sewer Commission No. 4** - Not exceeding \$3,000,000 General Obligation Bonds, in one or more series, not exceeding 8%, mature no later than March 1, 2028, (1) constructing, equipping and acquiring extensions and improvements to the waterworks plant and system and sewer and sewerage treatment and disposal facilities and (2) acquiring the necessary equipment and furnishings.
9. **L13-409 - St. Tammany Parish, Recreation District No. 14** - Not exceeding \$4,150,000 General Obligation Bonds, not exceeding 8%, not exceeding 20 years, purchasing, acquiring, constructing and improving parks, playgrounds, recreation centers and other recreational facilities and the necessary furnishings and equipment.
10. **L13-389 - Webster Parish, Dixie Inn Fire Protection District No. 7** - Not exceeding \$600,000 General Obligation Bonds, not exceeding 6%, not exceeding 10 years, acquiring, constructing and improving buildings, machinery and equipment, including fire trucks.
11. **L13-410 - Winn Parish Law Enforcement District** - ½% sales tax, to be levied in perpetuity, beginning January 1, 2014, (1) providing additional support for the Sheriff's Department, including but not limited to, acquiring, improving, maintaining and operating law enforcement facilities, vehicles and equipment and (2) funding general operations.
