TAB 5 - LOCAL POLITICAL SUBDIVISIONS - BONDS - FINAL APPROVAL

25. **L11-144 - East Baton Rouge Parish, St. George Fire Protection District No. 2** - Not to exceed \$5,400,000 Revenue Bonds, Series 2011, not exceeding 3%, not exceeding 5 years, (1) construct a fire station, an administrative facility and a new training facility, including all necessary furnishings and equipment; and (2) acquiring the site.
26. **L11-173 - East Carroll Parish, Lake Providence Port Commission** - Not exceeding \$3,700,000 Revenue and Refunding Bonds, Series 2011, (1) approximately \$893,000 Taxable Refunding Bonds, refunding Certificate of Indebtedness of Series 2005 and Series 2005A; (2) approximately \$2,857,000 Revenue Bonds, not exceeding 9%, not exceeding 30 years, constructing and acquiring improvements, extensions and replacements, extensions and replacements to various capital projects, and (3) funding a reserve fund.
27. **L11-222 - Orleans Parish, City of New Orleans, Audubon Commission** - Not exceeding \$25,000,000 Aquarium Tax Bonds, Series 2011A, in one or more series, approximately \$23,280,000 Refunding Bonds and approximately \$1,720,000 Revenue Bonds, not exceeding 6%, mature not later than October 1, 2021, (1) refunding the outstanding principal of the City of New Orleans Audubon Commission Aquarium Refunding Bonds, Series 2001 A&B; (2) making capital improvements to the Aquarium of the Americas and related facilities; and (3) paying the premium for a Municipal Bond Insurance Policy, if any.

28. **L11-207 - Pointe Coupee Parish, City of New Roads** - Not to exceed \$7,000,000 Utility Revenue & Refunding Bonds, Series 2011, in one or more series, to be issued as approximately \$2,000,000 Revenue Bonds and approximately \$5,000,000 Refunding Bonds, not to exceed 6%, not later than 20 years, (1) refunding portions of (a) Series 2007 Electric System Revenue Bonds (b) Series 2001 Electric System Revenue Refunding Bonds (c) Series 2001 Water & Sewer Revenue Refunding Bonds and (d) Series 2009 Water Meter Project Bonds; (2) acquisition, upgrade, expansion, and construction of City owned public improvements; (3) any other additions, acquisitions, repairs and/or expansions needed to maintain public improvements; and (4) funding a reserve fund, if necessary.
29. **L11-219 - St. Tammany Parish Council** - Not exceeding \$20,000,000 Utilities Revenue Bonds, in one or more series, not exceeding 6%, not exceeding 40 years, constructing, acquiring, extending and/or improving the combined sewage collection, treatment and disposal systems and waterworks treatment and distribution systems, including the acquisition of one or more existing utilities systems.
30. **L11-211 - St. Tammany Parish Law Enforcement District** - Not exceeding \$8,000,000 Limited Tax Revenue Bonds, not exceeding 6%, not exceeding 20 years, making capital improvements, including the acquisition of furnishings and equipment.
31. **L11-190 - St. Tammany Parish, City of Covington** - Not exceeding \$850,000 General Obligation Refunding Bonds, not exceeding 6%, mature no later than March 1, 2021, refunding the outstanding General Obligation Bonds, Series 2002.
32. **L11-191 - St. Tammany Parish, City of Covington** - Not exceeding \$2,900,000 Public Improvement Sales Tax Refunding Bonds, not exceeding 5%, mature no later than November 1, 2021, refunding the outstanding Public Improvement Sales Tax Bonds, Series 2002.
33. **L11-187 - St. Tammany Parish, Town of Pearl River** - Not exceeding \$1,800,000 Sales Tax Bonds, in one or more series, not exceeding 4%, mature on or before 22 years, acquisition, construction and installation of improvements, and extensions to the drinking water system.
34. **L11-205 - Terrebonne Parish Council** - Not exceeding \$11,765,000 Public Improvement Bonds, Series ST-2011, not to exceed 6%, not to exceed 15 years, (1) constructing, acquiring, extending and/or improving public works or capital improvements, including any necessary site, equipment or furnishings, and (2) providing for a reserve.
35. **L11-208 - Washington Parish, Bogue Lusa Waterworks District** - Not to exceed \$1,250,000 Water Revenue Bonds, not exceeding 6.5%, mature no later than 30 years, acquiring, constructing, improving and/or maintaining improvements, extensions and replacement of its waterworks system.

38. **S11-023 - Louisiana Community Development Authority (Density Utilities of Louisiana, LLC Project)** - Not exceeding \$6,000,000 Revenue Bonds, in one or more series, approximately \$5,280,000 Tax-Exempt (Volume Cap) and approximately \$720,000 Taxable, fixed or variable rate not exceeding 9% Taxable and 10% Tax-Exempt, mature not later than 30 years, (1) acquisition, construction, rehabilitation and equipping of one or more distributive sewer systems; and (2) providing a reserve fund.

(Impala Warehousing (US) LLC Project)** - Not exceeding \$95,000,000 Revenue Bonds, acquisition, construction, reconstruction, refurbishment, improvement and equipping of a marine terminal for the purpose of handling bulk materials to be located at the intersection of LA Highway 22 and LA Highway 44, in Burnside, Louisiana.

TAB 9 - PUBLIC TRUSTS - FINAL APPROVAL AND/OR SALE

40. **S11-011A - Calcasieu Parish Public Trust Authority (Mortgage Credit Certificate Program)** - Not exceeding \$20,000,000 Single Family Mortgage Revenue Bonds or Mortgage Credit Certificates (Volume Cap), not exceeding 6%, mature not later than December 31, 2043, (1) acquire certain mortgage notes secured by mortgages on owner occupied residential real or immovable property owned by low and moderate income persons in the Imperial Calcasieu Parish areas (Calcasieu, Cameron, Allen, Beauregard and Jefferson Davis Parishes); (2) make deposits into certain funds as may be required for security in marketing the bonds; and (3) pay capitalized interest.
41. **S11-018A - Louisiana Public Facilities Authority (Centenary College of Louisiana Project)** - Not exceeding \$15,500,000 Revenue and Refunding Bonds, in one or more series, approximately \$1,485,000 Revenue Bonds and approximately \$14,015,000 Refunding Bonds, not exceeding fixed rate of 3.95% and thereafter variable rate not to exceed 15%, mature not later than 25 years, (1) acquiring, constructing, installing and equipping of certain improvements and renovations to its educational facilities including, without limitation, concrete work, plumbing, roofing, equipment and fixtures, renovations to certain residence hall facilities, foundation repairs, building code enhancements, auditorium seating, campus signage, renovations to certain athletic facilities, landscaping, renovations to certain science hall classrooms, window replacements, lighting and energy conservation improvements, chiller and boiler replacements and general repairs; and (2) refunding all of the outstanding Revenue and Refunding Bonds Series 1999.
42. **S11-022 - Louisiana Public Facilities Authority (Performance Fuel Project)** - Not exceeding \$10,000,000 Revenue Bonds (Volume Cap), in one or more series, variable rate not to exceed 15% or fixed rate not to exceed 10%, mature not later than 40 years, (1) acquiring, constructing and installing a synthetic alternative fuel manufacturing facility; (2) renovating an existing building; (3) adding rail facilities to the site; (4) acquiring land; and (5) purchasing equipment therefor to be located in New Iberia.
