3. **L14-100 - Acadia Parish, Fire Protection District No. 8** - Not exceeding \$38,000 Certificates of Indebtedness, Series 2014, not exceeding 3%, mature no later than March 1, 2021, acquiring and equipping a fire truck.
4. **L14-132 - Caddo Parish, Sewerage District No. 2** - Not exceeding \$50,000 Certificates of Indebtedness, Series 2014, not exceeding 3.25%, mature no later than March 1, 2015, current expenses.
5. **L14-130 - Concordia Parish, Parishwide Hospital Service District** - Not exceeding \$325,000 Certificates of Indebtedness, Series 2014, not exceeding 5%, mature no later than March 1, 2015, current expenses.

14. **L14-126 - Orleans Parish, City of New Orleans, Sewerage and Water Board of New Orleans -** Not exceeding \$200,000,000 Sewerage Service Revenue Refunding Bonds, Series 2014, not exceeding 7.5%, maturing no later than December 1, 2044, **(1)** approximately \$126,215,000 Refunding Bonds, **(a)** refunding all or a portion of Sewerage Service Revenue Bonds, Series 1997, 1998, 2000, 2000B, 2001, 2002, 2003, 2004 and Sewerage Service Refunding Bonds, Series 2009, **(b)** funding a debt service reserve fund and other reserve funds, if required; **(2)** approximately \$73,785,000 Revenue Bonds, **(a)** extensions, improvements, enlargement, betterments, alterations, renewals and replacements to the sewerage system, including land, equipment and other real or personal properties, **(b)** funding a debt service reserve fund and other reserve funds, if required.
15. **L14-127 - Orleans Parish, City of New Orleans, Sewerage and Water Board of New Orleans -** Not exceeding \$115,000,000 Water Revenue and Refunding Bonds, Series 2014, not exceeding 7.5%, maturing no later than December 1, 2044, **(1)** approximately \$25,535,000 Refunding Bonds, **(a)** refunding all or a portion of Water Revenue Bonds, Series 1998 and 2002, **(b)** funding a debt service reserve fund and other reserve funds, if required; **(2)** approximately \$89,465,000 Revenue Bonds, **(a)** improving and expanding water treatment plants, **(b)** improvements, extensions, betterments and repairs to the public water system and **(c)** funding a debt service reserve fund and other reserve funds, if required.
16. **L14-128 - Orleans Parish, City of New Orleans, Sewerage and Water Board of New Orleans -** Not exceeding \$100,000,000 Drainage System Improvement and Refunding Bonds, Series 2014, not exceeding 7.5%, maturing no later than December 1, 2032, **(1)** approximately \$15,020,000 Refunding Bonds, **(a)** refunding all or a portion of Drainage System Bonds, Series 1998 and 2002, **(b)** funding a debt service reserve fund and other reserve funds, if required; **(2)** approximately \$84,980,000 Revenue Bonds, **(a)** construction, improvement and extension of the drainage system, **(b)** funding a debt service reserve fund and other reserve funds, if required.
17. **L14-131 - Rapides Parish, City of Alexandria -** Not exceeding \$10,000,000 Sales Tax Refunding Bonds, in one or more series, not exceeding 5%, mature no later than August 1, 2023, refunding all or a portion of Sales Tax Bonds, Series 2004.
18. **L14-129 - St. Helena Parish Police Jury -** Not exceeding \$2,150,000 Sales Tax Bonds, Series 2014, not exceeding 3.75%, not exceeding 10 years, improving, repairing and resurfacing public roads.
19. **L13-332A - Tangipahoa Parish, Town of Independence - (1)** Not exceeding \$1,425,000 Water Revenue Bonds, Series 2015B, not exceeding 2.75%, not exceeding 40 years, construct and acquire improvements, renovations and replacements to the waterworks system, including appurtenant equipment and accessories; **(2)** Not exceeding \$1,425,000 Bond Anticipation Notes, not exceeding 4%, not exceeding 18 months, interim financing.
20. **L13-334A - Tangipahoa Parish, Town of Independence - (1)** Not exceeding \$2,632,000 Sewer Revenue Bonds, Series 2015, not exceeding 2.75%, not exceeding 40 years, construct and acquire improvements, renovations and replacements to the sewerage system, including appurtenant equipment and accessories; **(2)** Not exceeding \$2,632,000 Bond Anticipation Notes, not exceeding 4%, not exceeding 1 year, interim financing.
21. **L13-391A - Tangipahoa Parish, Town of Independence - (1)** Not exceeding \$1,150,000 Water Revenue Bonds, Series 2015A, not exceeding 3.5%, not exceeding 40 years, construct and acquire improvements and extensions to the waterworks system, including appurtenant equipment and accessories; **(2)** Not exceeding \$1,150,000 Bond Anticipation Notes, not exceeding 4%, not exceeding 1 year, interim financing.
