4. **L14-375 - Allen Parish, Fire Protection District No. 5 - Not exceeding \$1,000,000 General Obligation Bonds, not exceeding 6%, not exceeding 15 years, acquiring, constructing, and improving buildings, machinery and equipment, including fire trucks.**
