5. Consideration and adoption of a Resolution authorizing the entering into of a State Funds Escrow Deposit Agreement regarding deposit of state funds relative to the Louisiana Debt Service Assistance Program and providing for other matters relative thereto.

Receipt and consideration of the report of sale of a not exceeding \$200,000,000 principal amount of State of Louisiana General Obligation Gulf Tax Credit Bonds Series 2006-A and \$200,000,000 State of Louisiana General Obligation Gulf Tax Match Bonds Series 2006-B, adoption of the award resolution, therefore, and other matters related thereto.
7. Consideration and Adoption of the 2006 Net State Tax Supported Debt (NSTSD) Report in accordance with Article VII Section 6(F) of the Louisiana Constitution of 1974, LA. R.S. 39:1367 et seq. and the Debt Limit Rule of the State Bond Commission.

Presentation by Department of Transportation regarding the status of the TIMED program, the proposed fall 2006 issuance of a Gasoline and Fuels Tax Revenue Bond Series 2006 issue in the approximate amount of \$403,000,000, and proposed additional issuance requirements in subsequent fiscal periods.
9. Presentation by Department of Transportation and Louisiana Transportation Authority regarding the current status and issues, inclusive of funding issues, of the Louisiana Transportation Authority - LA1 project.
