**TAB 3 - LOCAL GOVERNMENTAL UNITS - ELECTIONS (April 9, 2016)**

3. **L16-007 - Bossier and Caddo Parishes, Caddo-Bossier Parishes Port Commission** - 2.5 mills tax, 25 years, 2018-2042, (1) site acquisition and constructing, acquiring, improving and equipping docks and wharves, transfer and storage facilities, commercial and industrial facilities and other port, transportation and infrastructure facilities and improvements, and (2) paying the Commission's expenses of administering, maintaining, operating and marketing its facilities.
4. **L16-001 - Calcasieu Parish, Fire Protection District No. 1, Ward 1** - 5.05 mills tax, 10 years, 2017-2026, (1) maintaining and operating fire protection facilities, (2) paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service and (3) paying the cost of purchasing, improving or constructing fire protection facilities.
5. **L16-011 - Lafayette Parish, Bayou Vermilion District** (1) 0.75 mills tax, 10 years, 2017-2026, constructing, acquiring, improving, operating or maintaining facilities or other public improvements included in the master plan in existence at the time of such expenditure; (2) Not exceeding \$4,000,000 General Obligation Bonds, not exceeding 8%, not exceeding 20 years, constructing, acquiring and/or improving any work of public improvement included in the master plan in existence at the time of such expenditure.
6. **L16-002 - Tangipahoa Parish, Fire Protection District No. 1** - 5.0 mills tax, 10 years, 2017-2026, (1) purchasing fire protection equipment, (2) maintaining and operating fire protection facilities and equipment, (3) paying the cost of obtaining water and (4) salaries of employees.
7. **L16-003 - Tangipahoa Parish Council** - 4.0 mills tax, 10 years, 2017-2026, (1) maintenance, operation and development of health units and (2) promotion and conservation of public health.
8. **L16-004 - Tangipahoa Parish Council, Road Lighting District No. 2** - 16.62 mills tax, 10 years, 2017-2026, providing and maintaining electric lights on the streets, roads, alleys and public places.
9. **L16-005 - Tangipahoa Parish Council, Road Lighting District No. 4** - 15.29 mills tax, 10 years, 2017-2026, providing and maintaining electric lights on the streets, roads, alleys, and public places.

10. **L15-421 - Jefferson Davis Parish, Fire Protection District No. 4** - Not exceeding \$350,000 Excess Revenue Certificates of Indebtedness, not exceeding 4%, not exceeding 10 years, acquiring, constructing and improving other fire fighting equipment.

12. **L16-012 - Lafayette Parish, City of Lafayette** - Not exceeding \$2,100,000 Public Improvement Sales Tax Refunding Bonds, not exceeding 6%, mature no later than May 1, 2032, refunding all or a portion of Public Improvement Sales Tax Bonds, Series 2007B.
13. **L16-013 - Lafayette Parish, City of Lafayette** - Not exceeding \$14,500,000 Public Improvement Sales Tax Refunding Bonds, not exceeding 6%, mature no later than March 1, 2032, refunding all or a portion of Public Improvement Sales Tax Bonds, Series 2007A.
14. **L15-437 - Union Parish, Town of Farmerville** - Not exceeding \$1,000,000 Revenue Bonds, Series 2015, in one or more series, not exceeding 6%, not exceeding 20 years, construction of utility infrastructure, turn lane and related public improvements to enhance economic development within or adjacent to the Farmerville Economic Development Area.
15. **L16-010 - Vermilion Parish, City of Abbeville** - Not exceeding \$600,000 Revenue Bonds, not exceeding 4%, not exceeding 10 years, acquiring fire trucks and fire protection equipment.
